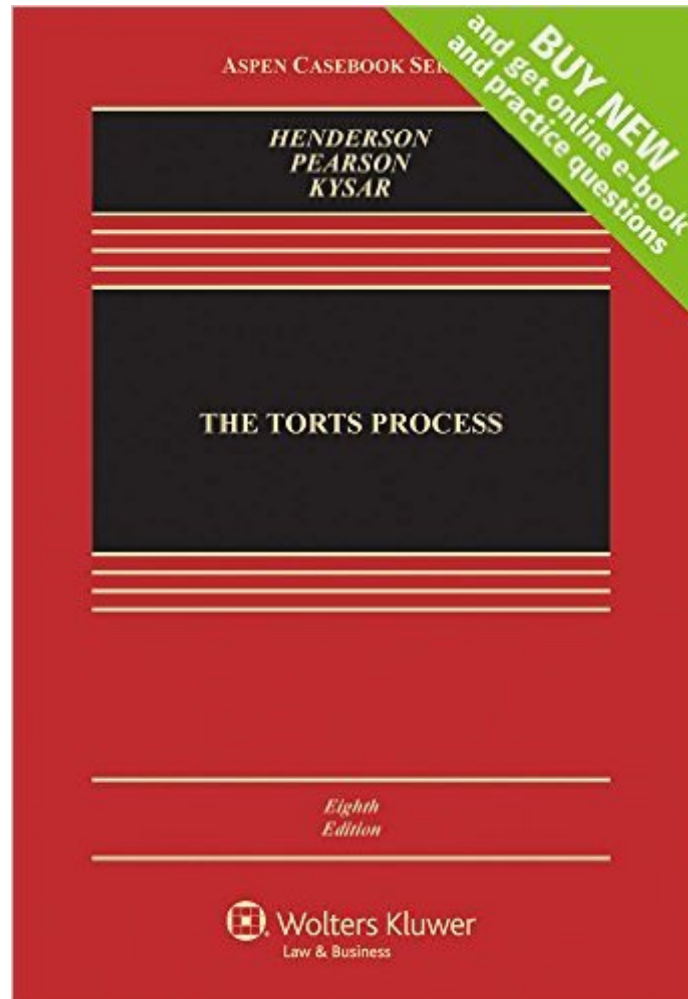

Phelps*, concerning constitutional limitations on intentional infliction of emotional distress liability. In addition, the Eighth Edition discusses the BP Oil Spill Fund in the chapter on alternative compensation mechanisms.
